We are requesting that all our sponsors e-mail your artwork and the information that you want to be displayed in our program booklet no later than May 29, 2026.

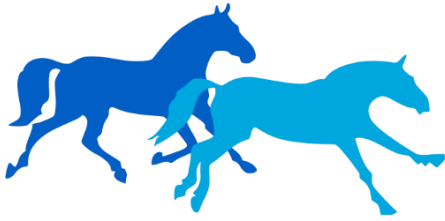
